The Institute for Plasma Research is a premier scientific institute under the Department of Atomic Energy, Govt. of India devoted to research and development activities in the areas of Basic Plasma Physics, Magnetic Confinement Fusion and Industrial and Societal applications of plasmas. IPR is located in Bhat Village and also has extensions of its Laboratories at GIDC, Sector – 25, Gandhinagar and has a Centre at Guwahati.

OR  Master's degree of a recognised university in any subject with Hindi and English as main subjects at degree level.  OR  Master's degree of a recognized university in any subject with Hindi/English Medium and English/Hindi as a main subject at degree level.  OR  Master's degree in Hindi/English or in any other subject with Hindi/English medium, with English/Hindi as main subject or a medium of examination at degree level.  OR  Bachelor's degree in Hindi and English as main subjects or either of the two as medium of examination and the other as main subject plus recognized diploma/certificate course in translation from Hindi to English and vice versa OR two years' experience of translation work from Hindi to English and vice versa in central/state government offices including government of India undertaking.

## **GENERAL INFORMATION**

- 1. Only Indian Nationals need to apply. The persons with disabilities can also apply against the unreserved quota.
- 2. Candidates are advised to submit only one application for a post. Submission of multiple applications for the same post may result in cancellation of applications altogether.

- 3. Candidates are advised in their own interest to submit online applications before the closing date and not to wait till the last date to avoid the possibility of disconnection/ inability or failure to login to the Institute's website.
- 4. All the qualifications must be from recognized Indian Universities / Boards / Institutions only. Applicants having qualifications from any other countries shall submit equivalency certificate from UGC / AIU.
- 5. Fulfilling minimum qualification & filing online application does not entail a call for Written Test and / or Interview. The authorities reserve all rights, not to call an applicant for Written Test and / or Interview, without assigning any reason. In case of any dispute / ambiguity that may occur in the process of selection, the decision of the Institute shall be final.
- 6. The applications received in response to the advertisement shall be scrutinized and only candidates shortlisted from valid applicants on the basis of all criteria like age, educational qualification, experience, category etc. shall be called for Written Test and / or Interview.
- 7. The Date of Birth as recorded in the Birth Certificate / Secondary School Leaving Certificate (SSLC)/ Matriculation / Secondary School Certificate shall be the only acceptable document in support of proof of age.
- 8. While applying the candidates should mention their full name as it appears on the Matriculation / Secondary School Certificate. If a candidate has changed his/her name or dropped or added part of his/her name after Matriculation / Secondary School they will have to submit an attested copy of Gazette Notification to this effect.
- 9. Candidates employed in Govt. / Quasi Govt. / Public Sector Undertakings should forward their applications through proper channel or bring NOC if called for Written Test and / or Interview. The Institute reserves the right to reject any application without assigning any reason. Incomplete applications are liable to be summarily rejected. No interim correspondence will be entertained.
- 10. Candidates seeking relaxation under SC/ST/OBC/PwBD or Ex-serviceman category are required to submit certificate in the prescribed format of Govt. of India.
- 11. Sleeper Class / Second Class to and fro Rail/ State Transport bus fare by direct and shortest route will be reimbursed to out-station candidates called for interview on production of ticket or proof of journey such as Railway / Bus ticket or ticket number.
- 12. In addition to pay and allowances, Medical Scheme, Free Transport, Subsidized Canteen facilities, LTC, New Pension Scheme are admissible as per IPR rules.
- 13. Experience shall be counted only after the date of possessing the essential educational qualifications. The eligibility criteria with regard to age, qualification, experience etc. shall be determined as on 30/09/2019.
- 14. IPR will carry out all correspondence regarding call for Written Test and / or Interview through email only and no postal correspondence will be sent.
- 15. Candidates are advised to regularly visit the Institute's website for getting the information about date of Written Test and / or Interview etc.
